

## Primary Source Analysis

Your primary source analysis is due by the start of class on Wednesday, October 30.

While you should summarize the general points of the primary source, remember that this is an analysis, not simply a summary. Use the questions provided on the handouts for primary sources earlier this semester (on Canvas) to guide you. Your analysis should reveal a knowledge of class discussions, lectures, and readings; **no outside sources are allowed**. Feel free to cite any of the readings (primary or secondary) that you think are relevant. Be sure to keep your analysis focused on the primary source that you've chosen from the below list, however.

### Paper Length and Formatting:

- Your primary source analysis should be between **two** and **three** pages in length.
- Please use 12 point, Times New Roman font, standard 1 inch margins, and double-space your paper. Since this paper has a length requirement, please be sure that you have removed the space after paragraphs. Include your name at the top of the first page, and be sure to include page numbers. You should refer to the Chicago Manual of Style for any citations.
